It is with mixed emotions that we announce the resignation of our Team Leader, Andrew Howard, from his position at FACT Bucks, effective Autumn 2024.


We are grateful for Andrew's commitment and hard work on behalf of the parents and carers of children and young people with additional needs in Buckinghamshire.

Holiday Activities & Food programme (HAF)



The HAF program receives cash from central government to provide physical activities and food for children in need during the main school holidays.

Up to 15% of its funding and places can be offered to CYP with SEND that do not meet the free school meal qualification test. HAF help more SEND kids in the holidays than the Bucks Activity Project.

FACT are represented on the HAF steering group.

Therapies update



In February, Bucks Healthcare Trust was awarded the renewed contract following the approval of the new Therapies Strategy, which is expected to have a positive impact on waiting lists. However, it remains uncertain whether these changes will counterbalance the growing number and complexity of cases.

Under the new contract, the NHS now provides therapies to children and young people in Additionally Resourced Provisions (ARPs) and SEN units, a responsibility previously managed and funded by the ARPs themselves. Therapy provision in special schools may soon be subject to increased scrutiny. Watch this space for more information as it develops.
